( Broward Trailer ) hereby warrants that each new model trailer will be free from defects under normal use in material and workmanship for the period of one (1) year from the date of delivery. The manufacturer, in replacing defective parts including related labor, under the conditions specified below, will honor this warranty.

This warranty does not apply to deterioration of appearance due to normal use, normal wear and tear, or to normal maintenance service. Paint is not covered by any warranty expressed or implied. All auxiliary parts such as brakes, axles, tires, suspension, and lights are covered by the warranty of their manufacturer. Trailer is not warranted for any particular fitness or use.

## Limited Warranty Claims

Warranty work must be performed at our factory, or a repair facility that we agree to. Warranty inquiries must include the Vehicle Identification Number ( VIN ) of the trailer, date of purchase, description of defect and /or nature of work to be performed, and the amount of claim. No warranty claims will be honored unless the claim has been presented to, and approved by our office and our office issues a warranty claim number, PRIOR to repairs being made. ## Terms and Conditions of Sale and Delivery

In the case that we are required to turn the collection of any monies over to an attorney or collection agency, the undersigned hereby agrees to pay reasonable cost, interest and attorney or collection agency's fees, including costs associated with filing of a lien/demand or payment from surety.

Manufacturer reserves the right to modify, without notice, specific designs and specifications as deemed advisable on the trailers described herein without obligation in regards to trailers previously sold. The manufacturer also reserves the right to discontinue any model or models without obligation in regards to trailers previously sold. Written warranty covers each trailer.
